



## Official Rules

### Club 55 Senior Day Promotion

Tuesdays: August 5, 12, 19 & 26

**4 Winners of \$150 Free Slot Play, every hour, 11am-8pm**

PEC membership and valid photo ID are required to enter contest. Membership is free. Winner must be 55 years or older.

#### **Entries**

All Player Extras Club members, ages 55 years and older, are eligible to earn, at no point reduction, one (1) Club 55 drawing entry per \$50 of carded play on slot machines or \$150 of carded play on Electronic Table Games [on Club 55 Senior Promotional Days](#). Eligible Club members must be playing with their Player Extras Club card properly inserted into the gaming machines in order to earn points and entries. Entries will be eligible for all future drawings on the day they are earned.

Entries must be activated approximately ten (10) minutes prior to the next drawing time in order to be eligible

#### **Earned Entries Drawing**

Every hour, 11am to 8pm, four (4) winners will be selected via a virtual drawing out of all eligible entries to receive \$150 Free Slot Play, valid for use on all video gaming machines (excluding Electronic Table Games). If the winner is present, they will need to visit the Player Extras Club with valid photo ID within 10 minutes from when their name was announced. If the winner is not present their prize will be reduced to \$50 Free Slot Play, which they will have 30 days from the drawing date to claim.

The names of the winners will be announced over the PA system throughout the gaming facility. Reporting to the Player Extras Club within 10 minutes from when the winner's name is announced is considered present for that hour's drawing. If a Winner reports to the PEC within 10 minutes, but does not have valid photo ID the winner will be given 30 days to claim their prize.

Club 55 members will also earn 2x entries into the next Grand Prize drawing each Tuesday.

It is possible that a Club member may win more than once throughout the day. However, a Club member can only win once per hour. All winners must produce valid photo ID to be determined a winner and claim their prize. Management will verify winners' identification and Club membership. If a Portal drawing cannot be completed a backup drawing procedure will be used instead.

#### **Exclusions:**

If the winner is currently banned or excluded from SCR, they will not be eligible to win and a new winner will be drawn.

#### **Additional Rules**
