

Official Rules

Christmas Tree Progressive Drawings

Fridays, December 7 & 28, 2012

3 winners via hot seat every hour from 1pm-10pm

PEC membership and valid photo identification are required to enter contest. Membership is free. Winner must be 18 years or older.

Player Extras Club members are eligible to win Free Slot Play on December 7 and 28, 2012 from 1pm-10pm in Saratoga Casino and Raceway's Christmas Tree Progressive Drawings. Three (3) winners will be selected each hour, via hot seat, to pick an ornament off the prize tree. Ornaments will have Free Play prizes ranging from \$100 to \$250. One of the ornaments will be the Progressive Prize. The Progressive starts at \$500 cash and increases by \$250 after every drawing time that it is not selected.

Entries

PEC members playing with their Club card inserted into any video gaming machine at the time of the drawing are eligible to win.

Drawings

The drawings will take place at the PEC every hour from 1pm-10pm on each drawing date. For each drawing, three (3) winners will be selected via CMP's Pick Random Players function. The winners will be announced via loud speaker and will be instructed to visit the PEC within 5 minutes of hearing their name announced to claim their prize. If a winner does not report to the PEC within 5 minutes, another winner will not be chosen.

Prizes

For each drawing, the winners will be asked to pick an ornament off the prize tree in the order they arrived at the Club. The ornaments will range from \$100- 250 Free Play, along with the progressive ornament. The progressive ornament will start at \$500 cash, and increase \$250 every hour it is not picked. Guests win the corresponding Free Play or Cash they pick. If the first guest selects the Progressive Prize, the 2nd winner that hour will not be able to win the progressive because that ornament was already picked for that drawing time.

After the 10pm drawing, the progressive ornament resets so that the following week it starts at \$500 cash.

If a guest is present, but does not have valid photo ID, they will be allowed to participate and will be given 30 days to present valid photo ID and claim their prize.

Exclusions:

If the winner is currently banned or excluded from SCR, they will not be eligible to win and a new winner will be drawn. If the winner was previously banned or excluded and their term has expired, the guest must fill out a NY Lottery Gaming Reinstatement Request form. After the guest has been approved for reinstatement, they will receive their prize.

Additional Rules
