Classic Car Giveaway

Earn Entries: July 1, 2013 – August 25, 2013

Drawing: Sunday, August 25, 2013

Guests can earn 10x entries on Mondays & Tuesdays in July & August.

Four (4) winners of \$100 Free Play (\$250 FP if present) at 12pm, 2pm, 4pm, 6pm & 8pm.

One (1) winner of a 1964 Corvette Stingray at 9pm.

Player Extras Club membership and valid photo ID are required to enter contest. Membership is free. Winner must be 18 years or older.

Entries

All Player Extras Club members are eligible to earn, at no point reduction, one (1) drawing entry per \$50 of carded play on slot machines, and \$150 of carded play on electronic table games. Guests can earn entries daily from July 1, 2013 – August 25, 2013. The drawings will be held on Sunday, August 25, 2013.

To be eligible for prizes, Club members must activate their entries on August 25 by properly inserting their Club card into any video gaming machine and recording slot play on their Club card. Entries must be activated approximately 30 minutes prior to the next drawing time in order to be eligible. Entries earned will be automatically entered into the drawing after the entries are activated with carded play on the day of the drawings. Once entries are activated they are eligible for all future drawings on Sunday, August 25, 2013. No entries will be activated after 8:30pm for the 9pm drawing.

Drawings

Four (4) winners will be selected out of all activated entries, via a virtual drawing, 12pm, 2pm, 4pm, 6pm & 8pm. Each will win \$250 Free Play if present or \$100 Free Play if not present.

One winner will be selected at 9pm to win the 1964 Corvette Stingray. There will be no cash out option for the winner. Winner need not be present.

The 1964 Corvette Stingray winner will be required to pay sales tax on the car (\$54,000 value). The winner will need to fill out Title & Registration paperwork with Roli's Motor Cars in Schaghticoke, NY. If the winner is unwilling or unable to pay the sales tax and fill out registration paperwork, the car will revert back to Saratoga Casino with no further compensation to the winner.

All winners must produce valid photo identification to be determined a winner. Management will verify winners' identification and Club membership. The names of the winners will be announced over the PA system throughout the gaming facility. Winners need not be present to win. If a winner is not present, he or she will be contacted the following business day to arrange delivery of the prize.

If they report to the PEC, but do not have proper photo ID, they will be given 30 days to come back and claim their prize. If they do not claim their prize within 30 days, their prize will be forfeited.

Exclusions:

If the winner is currently banned or excluded from Saratoga Casino and Raceway, they will not be eligible to win and a new winner will be drawn.
