



Official Rules

\$30,000 September Grand Prize

Earn Entries: September 1 – September 28, 2013

Drawings: Saturday, September 28, 2013

Four winners of \$250 Free Slot Play, \$150 if not present, every hour 1pm- 10pm

Two (2) winners of \$5,000 cash at 11pm

One (1) winner of \$10,000 cash at Midnight

Player Extras Club membership and valid photo ID are required to enter contest. Membership is free. Winner must be 18 years or older.

Entries

All Player Extras Club members are eligible to earn, at no point reduction, one (1) drawing entry per \$50 of carded play on slot machines or \$150 of carded play on Electronic Table Games from [September 1 through September 28, 2013](#). Club members must be playing with their Player Extras Club card properly inserted into the gaming machines in order to earn entries. Entries earned will be automatically entered into the drawing. To be eligible for prizes, players must activate entries on [Saturday, September 28, 2013](#) for the Grand Prize drawings by recording carded play.

Entries must be activated approximately 15 minutes prior to the next drawing time in order to be eligible. Once entries are activated, they are eligible for all future drawings on Saturday, September 28, 2013.

Grand Prize Drawing

Every hour, 1pm to 10pm, four (4) winners will each receive \$250 Free Slot Play, valid for use on all video gaming machines (excluding Electronic Table Games). If the winner is present, they will need to visit the Player Extras Club with valid photo ID within 10 minutes from when their name was announced. If the winner is not present, their prize will be reduced to \$150 Free Slot Play.

At 11pm, two (2) winners will be announced. The winners will each receive \$5,000 cash. Need not to be present to win. There is no bonus for being present.

At 12am, one (1) winner will be announced. The winner will receive \$10,000 cash. Need not to be present to win. There is no bonus for being present.

It is possible that a Club member may win more than once throughout the day. However, a winner can only win once per hour. The names of the winners will be announced over the PA system throughout the gaming facility. Reporting to the Player Extras Club within 10 minutes from when the winner's name is announced is considered present for that hour's drawing. All winners must produce valid photo ID to be determined a winner. Management will verify winners' identification and Club membership. If a Winner reports to the PEC within 10 minutes, but does not have valid photo ID the winner will be given 30 days to claim their prize.

Exclusions:

If the winner is currently banned or excluded from Saratoga Casino and Raceway, they will not be eligible to win and a new winner will be drawn.
