## Official Rules

### Pot O' Gold Drawings

Fridays: March 1, 15 and 22, 2013

One Winner selected, via Hot Seat, at random times between 2pm-11pm to participate.  
There will be a total of 10 winners on each promotion day.

PEC membership and valid photo identification are required to enter contest. Membership is free. Winner must be 18 years or older.

#### **Entries**

PEC members playing with their Club card inserted into any video gaming machine at the time of the drawing are eligible to win.

If a guest is present, but does not have valid photo ID, they will be allowed to participate and will be given 30 days to present valid photo ID and claim their prize.

#### **Drawings**

The drawings will take place at the PEC at random time between 2pm-11pm on each drawing date. For each drawing, one (1) winner will be selected via CMP's Pick Random Players function. The winners will be announced via loud speaker and will be instructed to visit the PEC within 5 minutes of hearing their name announced to claim their prize. If a winner does not report to the PEC within 5 minutes, another winner will be chosen.

#### **Prizes**

A basket will be filled with plastic coins. 10% of them will be marked with a green X (worth \$50) and one coin will be marked with a black X (worth \$250). Using only one hand, players will have thirty (30) seconds to collect as many winning coins as they can find in the basket.

First \$250 in prizes will be awarded as Free Play. The rest will be awarded as cash.

#### **Exclusions:**

If the winner is currently banned or excluded from SCR, they will not be eligible to win and a new winner will be drawn.

#### **Additional Rules**
