

Platinum Voice Singing Promotion

Rules and Regulations

Auditions: September 25 & 26, 2013

Competitions: October 17, November 21 and December 19

Grand Prize: One (1) winner will win \$5,000 cash. Participants must be 21 years or older and have valid photo ID.

Entries

Thirty (30) will be chosen during auditions on September 25 and September 26. The contestants will be chosen by "blind" audition and will be split among three (3) teams—ten (10) contestants on each radio station team. They will then compete during the events in October, November and December until the grand prize winner is chosen.

Auditions

Contestants can enter one of two (2) ways.

Website entries

Contestants will be able to enter via Albany Broadcasting websites with a video and/or audio submission. Fifteen (15) contestants will be chosen and will receive a guaranteed audition.

On-Site

Listeners will be encouraged to come to the auditions and enter to win. Contestants will be randomly picked to perform (acapella). During the two (2) hour period, contestants will be drawn at random to audition for their chance to impress the judges between 7:30pm and 9:30pm. All registration and check in must be complete by 7:30pm with no exceptions.

No one who is currently signed with a label will be allowed to compete.

Contestants MUST be 21 years old at the time of audition

The winner from Platinum Voice 2012 IS NOT eligible to participate in the 2013 competition
All other participants (those who auditioned and those who competed) are eligible to compete in 2013

Contest

Each team (FLY 92.3, Jamz 96.3 and 104.9 The Cat) will be ten (10) contestants. The contestants will be required to return to Vapor each competition night to perform again. Each contestant participates on their own will and will not be reimbursed for their time and/or gas.

The grand prize winner will receive \$5,000.00 (payable by check). The grand prize winner will be responsible for all taxes associated with the grand prize.

At the audition events, the judges will be making the decisions for their team. At the monthly events (October, November and December) the winners will be chosen based on a combination of audience participation and judges' decision.
